

CITY OF CHEHALIS
BID SPECIFICATIONS AND PROPOSAL FOR CHLORINE AND SULFUR DIOXIDE

In accordance with the specifications, Seller proposes to furnish the following products to the City of Chehalis for the unit prices shown for the period from August 1, 2006 through July 31, 2008. All prices quoted shall be F.O.B. Chehalis storage facilities. Delivery by Seller shall be made in open carrier to facilitate unloading by City. All delivery vehicles will be driven by persons trained in chlorine safety; vehicles shall carry the appropriate leak repair kit(s).

Billings by Seller will be made directly to City.

Seller shall enter into an indemnification agreement with City, holding the City of Chehalis harmless from any and all bodily injury and property damage liability claims arising from the delivery of chlorine and/or sulfur dioxide. Seller shall provide proof of liability insurance in amounts not less than Five Hundred Thousand and no/100ths dollars (\$500,000) insuring against such damages.

Seller shall submit with the bid document a record of any safety violations occurring during transport and delivery of chemical products during the preceding five- (5) year period.

Seller must include a copy of its emergency spill response plan.
